#### **General terms and conditions**

# 1. Registration and invoicing

Registration must be made in writing. You will find the corresponding registration form on our website:

Registration is confirmed on receipt of payment of the full amount. Upon receipt of the registration form, any withdrawal will result in the invoicing or deduction of the administration fees detailed under point 6 of the general terms and conditions. The deadline for online registration is no later than 20 days before the start of the school holidays. Registration by telephone at shorter notice is possible if places are still available. Registrations are taken on a first-come, first-served basis. In the event of overbooking, a waiting list will be drawn up.

Three days before the start of the holiday program, you will receive a letter with detailed information.

# 2. profawo's responsibility

profawo offers a varied weekly program tailored to the age and needs of the children, and guarantees professional care.

# 3. Costs

The cost is CHF 525. -- per week, per child. Member discount of CHF 50. -- per week, i.e. CHF 475.

An invoice will be sent to you on receipt of your enrolment. Payment must be made within 10 days.

# 4. Terms of payment

Registration is valid on receipt of payment and is then considered definitive.

### 5. Cancellation

If you wish to cancel your child's registration, we will charge you the following fees:

- For cancellations up to 60 days before the start of school holidays: no handling fee
- For cancellations <u>up to 30 days before</u> the start of the school holidays: 50% of the enrolment fee and CHF 30 administration fee\*.
- In the event of subsequent cancellation, illness or other absence: no refund of fees already paid.



\* for any contribution already paid: 50% of the fee will be refunded after deduction of the administration fee. Please enclose a BVR with your written cancellation request or provide us with your IBAN number or post office account number.

### 6. Media authorisation

During the activities, staff take photos of the group of children. These photos are sent to the parents of the children taking part.

The photos may be published on our website or on social media after consultation with the parents. If you do not wish any images of your child to be published, please let us know when you register and we will inform the staff.

### 7. Insurance

Parents are responsible for their child(ren)'s accident and civil liability insurance.

# 8. Data protection

The personal data of participants and their parents required to manage the holiday program will only be used by profawo and will not be passed on.

# 9. Competent court

The exclusive place of jurisdiction is Berne.
